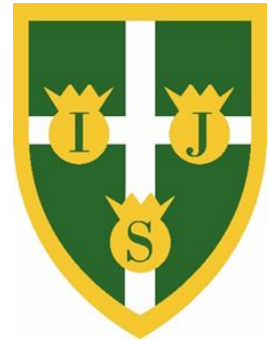

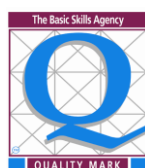
GOVERNANCE ARRANGEMENTS

The Governing Body of Ingrave Johnstone was re-constituted in 2015 and is made up of 12 members. It is made up of two staff governors (including the Headteacher), two elected Parent Governors, one Local Authority Governor and seven Foundation Governors. All of our Governors serve a four-year term of office.

Foundation Governors are appointed by one of two bodies, either the Diocese of Chelmsford or the PCC of the Anglican parish of St Nicholas Church, Ingrave. Our Foundation Governors include the Incumbent of the Anglican Parish St Nicholas, Ingrave, parents of existing pupils and regular members of the St Nicholas Church community.

All Parents are entitled to stand for election as a Parent Governor when a vacancy arises.

Our Full Governing Body meets twice each term, to receive reports on children's progress and achievement as well as monitoring the budget and to set strategic Policy and direction for the school.

GOVERNANCE 2022-23

We are now well past Covid which presented unprecedented challenges for everyone, and it has been wonderful to see a full year of uninterrupted teaching and learning at the school. The entire school community of staff, pupils and parents have had much to adapt to since Covid and it is fantastic to see normal school life back once again, with school performances, corporate worship, school visits and school events once again able to take place. We have had the additional challenge of maintaining a good education of our children while coping with industrial action by some of the teachers, something that the Governing Body supports. Governors at Ingrave Johnstone are always highly involved with their key statutory roles.

In terms of safeguarding at our school, Ms Sarah Stefano is the nominated governor for safeguarding. Mr Rogers, our Headteacher, advises Governors of any safeguarding issues which have arisen at our termly meetings. At our Resources meeting we oversee the management and implementation of the school budget, which is prepared annually by the school Business Manager, with input from the Headteacher and Senior Leadership Team. It is agreed by the whole Governing Body. There is a great responsibility to spend public money wisely and after several years of budget cuts we are pleased to report that the school and our Governors have maintained a balanced budget for



2022/2023 and is on course to achieve the same in 2023/2024. The committee is provided with a comprehensive report which details spending and any deviation from the budget. Adhering to the budget is becoming increasingly challenging with the present financial climate.

Regarding premises, our Health and Safety Governor carries out termly inspection walks together with our Site Manager. We are also very grateful to the Parents Association for providing us with funding that helps our children obtain those “extra” things that we would not ordinarily be able to afford.

The Governing Body has discussed key data and results of pupil attainment and progress, so that we are sure that the school is on track to fulfil our ambitious targets for all pupils. We regularly monitor the progress of our disadvantaged pupils and those with Special Educational Needs, looking at how the Pupil Premium funding is spent and what impact this has on their well-being, learning and development. You will find details about this on our website.

Governors consistently review and agree school policies throughout the year, many are model policies supplied by Essex County Council or are based on Department for Education guidance. Whenever it is appropriate, pupils and parents are consulted regarding their views on policy updates and amendments as in the case of our Behaviour, Discipline and Anti-bullying and our Home Learning policies.

Governing Body meeting minutes (apart from confidential items) are public documents. They can be viewed at the school office.

GOVERNORS' PLANS FOR 2023-24

Our plans for 2023-24 include:

- Ensuring that our children receive a high quality education in a nurturing and supportive environment in line with our core values and school Christian Vision.
- Continuing to monitor the levels of progress and attainment across the school.
- Continue to monitor the school's performance against the recommendations from the last OFSTED report of June 2018 and against the schools own internal annual School Improvement Plan. We are overdue a new inspection and expect this during this school year. The staff and governors have spent a good amount of time preparing for this.
